4. FIRST AID MEASURES

Eye contact:	Check for and remove any contact lenses. Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.

6. ACCIDENTAL RELEASE MEASURES

Use explosion-proof electrical (ventilating, lighting and material handling) equipment. Use non-sparking tools. Take precautionary measures against electrostatic discharges. To avoid fire or explosion, dissipate static electricity during transfer by grounding and bonding containers and equipment before transferring material. Use empty containers to retain product, residue can be hazardous. Do not reuse container. Store in accordance with local regulations. Store in a segregated and approved area.
