## 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

**Storage:** approved alternative made from a compatible material, kept tightly closed when not in use. Use empty containers to retain product, residue can be hazardous. Do not reuse container. 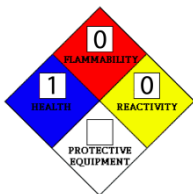
